Jeremy Tarr, Electric Superintendent:

- Capability testing was last week. Three engines passed and the last one will be tested when it is fixed.
- There have been some outages. There is an issue in the substation, & JEO is working with Jeremy to figure out the problem.
- There was an outage on Westridge this morning.
- They are working on South 3<sup>rd</sup> and at the airport.

Darren Marten, Water/Sewer Superintendent:

- They are chlorinating and disinfecting pipe for the highway project.
- The guys are potholing to prepare for boring along the highway.
