Budgets were discussed. The Board would like to know what is decided for street lights. The Board would like to see prices for boring highway 2, from more than one place. The cost, usage, and necessity of a new jet tuck was discussed.

- They are waiting on the repairs for the power plant.
- There were some outages over the weekend.
