## Broken Bow City Council Meeting Minutes October 27<sup>th</sup>, 2015

The Broken Bow City Council met in regular session on Tuesday, October 27<sup>th</sup>, 2015. Notice of the meeting was given in advance thereof as required by law. Said resolution authorized the payment #5 to Myers Construction, Inc. in the amount of \$321,715.80 for work completed through September 30<sup>th</sup>, 2015, on the 5<sup>th</sup> Avenue – Highway 2 to Memorial Drive Project. Roll call vote: Voting aye: Schall, Adams, Sonnichsen, and Schmick. Nays: none. Motion carried.

Moved by Schall, seconded by Sonnichsen, approving Resolution 2015-41. Said resolution authorized the payment #7 to JEO Consulting Group, Inc. in the amount of \$16,146.40 for work completed through October 16<sup>th</sup>, 2015, on the 5<sup>th</sup> Avenue – Highway 2 to Memorial Drive Project. Roll call vote: Voting aye: Adams, Sonnichsen, Schmick, and Schall. Nays: none. Motion carried.

Moved by Schall, seconded by Sonnichsen, approving Resolution 2015-42. Said resolution authorized the payment #8 to JEO Consulting Group, Inc. in the amount of \$1,020.00 for work completed through October 16<sup>th</sup>, 2015, on the 2015 Downtown Improvements Project. Roll call vote: Voting aye: Sonnichsen, Schmick, Schall, and Adams. Nays: none. Motion carried.

Mayor Burt opened the floor for comments from the Mayor and Councilmembers concerning City Departments: Councilman Cody Schmick formally submitted his resignation from the Broken Bow City Council effective December 31<sup>st</sup>, 2015, unless a replacement is found prior. Councilman Schmick thanked the entire community for their support, and he has been grateful for having had the opportunity to serve on the board for the past 4 years. He said his personal schedule has become far too hectic to give the board the due diligence expected and deserved.

Mayor Burt opened the public comment section of the meeting for those in attendance: Deb McCaslin, Interim Executive Director for the Custer Economic Development Corporation (CEDC) introduced herself in her new role. She thanked Councilman Schmick for all that he has accomplished as a Councilman and wished his the best in his future. Deb indicated how excited she was to be a part of CEDC in this capacity and has been hitting the ground running.
