

**Broken Bow City Council  
Meeting Minutes  
April 28, 2020**

The Broken Bow City Council met in regular session on Tuesday, April 28, 2020 via teleconference. Notice of the meeting was given in advance thereof as required by publication in the Custer County Chief on April 23, 2020. Availability of the agenda and related materials was communicated in the advanced notice to the Mayor and all members of the Council, as well as, shared with various media outlets. All proceedings hereafter shown were taken while the meeting was open to the attendance of the public.

Mayor Rod Sonnichsen called the meeting to order at 6:03 P.M., with the following Councilmembers present: Holcomb, Schmidt, Myers, and Miller. Absent: None. Mayor Sonnichsen announced the availability of the open meetings law.

Moved by Holcomb, seconded by Schmidt, to adjourn the City Council Meeting at 6:44 p.m. Roll call vote: Voting aye: Holcomb, Myers, Miller, and Schmidt. Nays: None. Motion carried.
