

**Broken Bow City Council
Meeting Minutes
February 8, 2022**

The Broken Bow City Council met in regular session on Tuesday, February 8, 2022, in the Broken Bow Municipal Auditorium. Notice of the meeting was given in advance thereof as required by publication in the Custer County Chief on February 3, 2022. Availability of the agenda and related materials was communicated in the advanced notice to the Mayor and all members of the Council, as well as, shared with various media outlets.
