- Fixed a sensor at the Wastewater Treatment Plant.
- Had a sledge pump go down, had electric department help fix it.
- Completed the fire hydrant repairs at Melham.
- UV lights are up and running at the treatment plant.
- Met with JEO on preliminary for the Highway 2 project.
