The following were discussed under Department Head Updates:

Blake Waldow, Electric Superintendent:

- A 3-phase cabinet was hit at Tractor Supply.
- Hired a journey man lineman, he will start March 12, 2025.
- Cutting trees on the south side of town.
- Streetlights around the school have been fixed.
- Took some generators to Kearney for repairs.
- Planning Spring and Summer projects.
- Need to replace a hydraulic line on Truck 69.
- Ran engines 4 and 5 at the power plant ran on diesel wouldn't work on gas.

Ryan Jones, Water/Sewer Superintendent:

- Well #7 on South 8th is not in use due to bad water sample, emergency backup only.
- A flow meter blew and well house was ¾ full of water, looking into abandoning well #7.
- Jetting as the weather permits.
- Lost hydraulic pressure on jet truck.
- Removing concrete at the treatment plant and will have it ground up for streets.
- Sargent Pipe is doing efficiency tests on the wells.
- JB Ross fixed the electrical problems at the well house.
