Broken Bow City Council

Meeting Minutes March 11th, 2025

The Broken Bow City Council met in regular session on Tuesday, March 11th, 2025, in the Broken Bow Municipal Auditorium. Notice of the meeting was given in advance thereof as required by law by posting in three public places: Broken Bow Municipal Building, Broken Bow Post Office, and the Custer County Courthouse. Advance notice of the meeting, a copy of the agenda, and related council materials were given to the Mayor and all members of the City Council and shared with various media outlets. All proceedings hereafter shown were taken while the meeting was open to the attendance of the public.

Mayor Rod Sonnichsen called the meeting to order at 6:00 pm, with the following Councilmembers present: Russ Smith, Travis Kleeb, Joe Wamsley, and Paul Holland. Absent: None. Mayor Sonnichsen announced the availability of the Open Meetings Act, followed by reciting the Pledge of Allegiance.

Moved by Smith, seconded by Kleeb to approve the consent agenda for March 11, 2025. Said motion includes approval of the Minutes of the March 3, 2025, Council Meeting, Bills to Date, and the January 2025 Treasurer's Report. Roll call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried.

In other communication, Emergency Services Director David Baltz gave an EMS update and explained that in 2024 they received a new record of 502 calls resulting in 3,496 service call man hours. 78% were 911 calls, 14% transports, 6% standbys, and 2% ALS intercepts. He reported that during the first two months of 2025 they are already at 106 service calls and that the roster consists of 7 Paramedics, 4 advanced EMT's and 21 EMT's. He also explained that the new ambulance will

arrive in late May or early June and that the department has three people enrolled at CCC to become paramedics. Mayor Sonnichsen commended the department for all they do.

Electrical Superintendent Blake Waldow also gave an update regarding the power plant explosion on February 20, 2025. He said that on the morning of the explosion, generation was called for by the Southwest Pool and all engines were online by 5:30 am. After the event happened, at 6:43 the town lost power with the majority of the town resuming power at 7:16 am. Left without power were approximately 240 residential and 60 commercial meters. NPPD quickly sent a mobile substation to aid in restoring temporary power but at 11:00 pm the call to not energize was made due to a mechanical failure. The next morning a new unit was sent out and power was restored around 2:00 pm on February 21st.

Mr. Waldow said that moving forward, to get these meters off of the mobile sub, the voltage conversion project that was going to happen over the next couple of years has now been moved up and they are pushing to have it done in the next 2-4 months. They will start on the north side then they will move to the south side where most of the businesses are. He also thanked everyone that helped during the outage. They included: the City Electrical Department, NPPD, Custer Public Power, BB Fire Department, EMS, MEAN, BNSF, City Staff, local motels, and the people and businesses who donated food and supplies during the event. He also ended by discussing the outages during the next two days as they begin the voltage conversion and stated that all the information and a map is posted on the City of Broken Bow Facebook page. He said that they plan to give as much advance notice as possible to those affected but explained that it is hard to give exact times in situations like this. He finished by saying that the City of Ord and the Village of Stewart are also helping provide mutual aid over the next few days. Mayor Sonnichsen concluded by reminding everyone that the portion of the town that was without power is on temporary electricity so that the sooner we can get them switched over, the better off we will be.

In new business, moved by Holland, seconded by Wamsley, to approve the designation of the BRAN host community event on June 3, 2025, as an official city special event. During discussion Scotti Ross of the CEDC and Stephanie Grafel of the Broken Bow Chamber of Commerce spoke about the background of the event, the current plan for the 300-600 BRAN riders while they are in the City of Broken Bow and the scholarship available for the host community. Administrator Schmidt also explained that by approving this as an official city special event, it also allows food trucks to park on the square if the committee decides that they need to utilize the square during the event. Roll Call Vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Wamsley, seconded by Holland to open a public hearing at 6:23 pm regarding Ordinance 1295, providing for the placement of a designated stop sign located on the north side of the S. 8th Avenue and S. D St. intersection in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried. Discussion was held. Captain Anderson of BBPD reiterated that they have had complaints regarding trucks speeding through and not paying attention to pedestrian traffic as they go by the city square causing a safety concern. He also explained that this road is a straight path to the highway and that is why there is so much truck traffic. Mayor Sonnichsen expressed that this has been problem area in the past and that there is a lot of pedestrian traffic around the square, especially during market on the square.

Stephanie Grafel of the Broken Bow Chamber of Commerce stated that she thought that the stop sign would be on the south side and that she is in favor of the intersection having a 4 way stop instead because she witnesses semi traffic gunning the intersection to try to make green lights. Jeremy Shipe of KCNI, expressed listener concerns relayed to him centered around the idea that it may be confusing only being a 3 way stop rather than a 4 way stop at this intersection. Chief Scott stated that he would be in support of a 4 way stop instead of a 3 way stop at this intersection as well. Moved by Kleeb, seconded by Wamsley to close public hearing at 6:33 pm. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Smith, seconded by Wamsley, to <u>not</u> waive the two readings of Ordinance 1295, providing for the placement of a designated stop sign located on the north side of the So. 8th Ave and S. D St. intersection in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion Carried.

The second reading of Ordinance 1295 was performed by City Clerk Jennifer Waterhouse.

Moved by Holland, seconded by Smith to open a public hearing at 6:35 pm regarding Ordinance 1296, providing for the placement of stop signs located at S. 6th Ave and S. C St., S. 7th Ave and S. C St., a four way stop at the S. 6th Ave and S. D St. intersection and a four way stop at S. 7th Ave and S. D St. intersection in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried. Discussion was held. Mayor Sonnichsen reiterated that two intersections addressed in the Ordinance have proposed 4 ways stops due to increased pedestrian traffic around the library and increased usage as school children are being bused to the library. He also explained that the intersection at S. D St and S. 7th Ave is a blind intersection going to the North and that the two intersections on South C Street have been suggested due to population growth in the area and traffic congestion centered around the Legacy Apartments, where it has grown from 4 occupied residences to 42. Captain Anderson added that many of the intersections addressed in the Ordinance are really difficult intersections that contribute to lots of accidents and the police department would like to control these intersections better with the additional stop signs. Discussion was held regarding if the stop signs proposed on the North and South sides of So. C Street should instead be on the East and West sides of the intersections.

Corey Clay, a resident at 911 Nome Street, spoke in support of the Ordinance referencing the safety of pedestrians and the speeding he has observed in the area. Moved by Holland, seconded by Kleeb to close public hearing at 6:45 pm. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Smith, seconded by Kleeb, to <u>not</u> waive the two readings of Ordinance 1296, providing for the placement of stop signs located at S. 6th Ave and S. C St., S. 7th Ave and S. C St., a four way stop at the S. 6th Ave and S. D St. intersection and a four way stop at S. 7th Ave and S. D St. intersection in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion Carried.

The second reading of Ordinance 1296 was performed by City Clerk Jennifer Waterhouse.

Moved by Wamsley, seconded by Kleeb to open a public hearing at 6:46 pm regarding Ordinance 1297, providing for the placement of stop signs at the N. 9th Ave and N, H St. intersection creating a four way stop in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried. Discussion was held. Administrator Schmidt started by presenting some alternative options to stop signs for this intersection. He explained that Darren Marten, Overseer of Streets found a speed limit sign with radar that cost \$4,000-\$5,200 depending on the features, and a flashing solar sign for \$1,200-\$1,800. The possibility of putting a cross walk and pedestrian sign at the intersection was also discussed. Captain Anderson stated that the Police Department is willing to look at all options but that their concern is that driver's still must drive partly out into the intersection to be able to see across causing a concern for public safety. Andrew Lacy also pointed out that there are no East and West sidewalks by this intersection. Jeremy Shipe mentioned how on street parking on N. 9th Ave may contribute to a bottle neck issue. Corey Clay expressed his concern regarding pedestrian safety at the intersection.

Installing better signage near the intersection and the DOT Traffic Standard were also discussed. Mayor Sonnichsen explained that the DOT Traffic Standard states that stop signs can not be installed for speed control and that they can only be used for safety reasons. The speed limit and speed transition going south into town as well as possibly coordinating different signage with the township was also discussed. Mayor Sonnichsen stated that there may need to be some adjustments to the Ordinance as it is currently written. Chief Scott ended by stating that he feels that the four-way stop needs to be installed as it forces vehicles to stop and gives children a chance to safely cross the road at this intersection. Moved by Holland, seconded by Kleeb to close public hearing at 7:06 pm. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Kleeb, seconded by Wamsley, to <u>not</u> waive the two readings of Ordinance 1297, providing for the placement of stop signs at the N. 9th Ave and N. H St. intersection creating a four way stop in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion Carried.

The second reading of Ordinance 1297 was performed by City Clerk Jennifer Waterhouse.

Moved by Wamsley, seconded by Holland to open a public hearing at 7:08 pm regarding Ordinance 1298, providing for the speed limit change to 25 mph for all of S. B St. west of S. 10th Ave in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried. Discussion was held. Captain Anderson stated that the Ordinance would be returning the residential street back to 25 mph which has been confusing to the public as they expect all residential streets to be 25 mph. Mayor Sonnichsen also said that this change would put the speed limit in sync with the rest of the residential speed zones in Broken Bow. Moved by Kleeb, seconded by Smith to close public hearing at 7:10 pm. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Smith, seconded by Wamsley, to <u>not</u> waive the two readings of Ordinance 1298, providing for the speed limit change to 25 mph for all of S. B St. west of S. 10th Ave in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion Carried.

The second reading of Ordinance 1298 was performed by City Clerk Jennifer Waterhouse.

There were no public comments.

During Mayor and council comments, Administrator Schmidt explained that a payment listed in the consent agenda for maintainer repair under the parks department got coded to miscellaneous expense on accident but that it has already been correctly reallocated to the parks department snow budget. He also explained that the City of Broken Bow will be waiving all utility account late fees this month due to a postal mix up that caused citizens to receive their utility bills very late. Mayor Sonnichsen concluded the meeting by thanking everyone for attending the council meeting and offering their comments.

Moved by Smith, seconded by Holland, to adjourn the City Council meeting at 7:13 pm. Roll Call vote: Voting aye: Smith, Kleeb, Wamsley, and Holland. Nays: None. Motion Carried.

Meeting Minutes March 3rd, 2025

The Broken Bow City Council met in regular session on Monday, March 3rd, 2025, in the Broken Bow Municipal Auditorium. Notice of the meeting was given in advance thereof by publication in the Custer County Chief, the designated method for giving notice. Advance notice of the meeting, a copy of the agenda, and related council materials were given to the Mayor and all members of the City Council and shared with various media outlets. All proceedings hereafter shown were taken while the meeting was open to the attendance of the public.

Mayor Rod Sonnichsen called the meeting to order at 6:00 pm, with the following Councilmembers present: Russ Smith, Joe Wamsley, and Paul Holland. Absent: Travis Kleeb. Mayor Sonnichsen announced the availability of the Open Meetings Act, followed by reciting the Pledge of Allegiance.

Moved by Holland, seconded by Wamsley, to excuse the absence of councilmember Kleeb. Roll call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Smith, seconded by Wamsley to approve the consent agenda for March 3, 2025. Said motion includes approval of the Minutes of the February 11, 2025, Council Meeting and Bills to Date. Roll call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried.

In new business, moved by Holland, seconded by Smith, to approve the Memorandum of Understanding between the City of Broken Bow and Brookestone View for handi bus utilization in the event of an emergency. During discussion Roni Boeser, Administrator of Brookestone View, explained that they do not have a wheelchair accessible bus and that the MOU will allow them to use the city handi bus to evacuate residents in the event of a disaster. Roll Call Vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Smith, seconded by Holland to approve Highway 2 Sanitary Sewer Extension 15th to Webster Change Order #1 with JEO Consulting Group Inc., moving the "substantial completion" milestone date from December 1, 2024, to March 1, 2025. Roll Call Vote: Voting aye: Smith and Holland. Abstain: Wamsley. Nays: None. Motion carried.

Moved by Holland, seconded by Smith to approve Highway 2 Sanitary Sewer Extension 15th to Webster Change Order #2 with JEO Consulting Group Inc., for adding 8" by 8' wide concrete with rebar at 24" O.C. to protect sewer main (80 linear feet), in the amount of \$9,280.00. Roll Call Vote: Voting aye: Smith and Holland. Abstain: Wamsley. Nays: None. Motion carried.

Moved by Holland, seconded by Wamsley, to approve Resolution 2025-01, Approving and authorizing the City Administrator to send notice to Custer County of the City of Broken Bow's desire to terminate the current Interlocal Cooperative Agreement for the Custer County Communications Center between Custer County and the City of Broken Bow, Nebraska. During discussion, Mayor Sonnichsen explained that this agreement has been in place since 2000 and to renegotiate the agreement, the city must give notice to terminate which will start the renegotiation process. He also added that this is a one-year notice. Roll Call Vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Wamsley, seconded by Smith to open a public hearing at 6:09 pm regarding Ordinance 1295, providing for the placement of a designated stop sign located on the north side of the S. 8th Avenue and S. D St. intersection in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried. Discussion was held. Mayor Sonnichsen explained that all the Ordinances being discussed at the meeting are recommended based on traffic and that council ran out of time last year addressing the issues. He also advised that council not waive the readings which would allow for public transparency and give Councilmembers time to research each additional options. He explained that Ordinance 1295 is for the placement of a stop sign by Brunning Bank where truck traffic is going past the city square and presenting safety concerns.

Councilmember Smith explained that this specific stop sign would cause the truck traffic to slow down and will keep the pedestrians safe. Captain Anderson of BBPD explained that they have had complaints regarding trucks speeding through and not paying attention to pedestrian traffic. Administrator Schmidt stated that this request comes from the Park Board and that the only citizen comment he has received was centered around if it should be a four way stop instead so that the north bound traffic would be forced to stop as well. He pointed out that although Ordinance 1295 is not currently written to include a four-way stop, it could be rewritten to include that. Moved by Holland, seconded by Smith to close public hearing at 6:14 pm. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Smith, seconded by Wamsley, to <u>not</u> waive the three readings of Ordinance 1295, providing for the placement of a designated stop sign located on the north side of the So. 8th Ave and S. D St. intersection in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion Carried.

The first reading of Ordinance 1295 was performed by City Clerk Jennifer Waterhouse.

Moved by Smith, seconded by Wamsley to open a public hearing at 6:16 pm regarding Ordinance 1296, providing for the placement of stop signs located at S. 6th Ave and S. C St., S. 7th Ave and S. C St., a four way stop at the S. 6th Ave and S. D St. intersection and a four way stop at S. 7th Ave and S. D St. intersection in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried. Discussion was held. Mayor Sonnichsen explained that the two intersections addressed in the Ordinance on South C Street have been suggested due to population growth in the area and traffic congestion. He noted that the area went from eight households previously to forty-two currently and it has resulted in many close calls facilitating the need to address the new traffic issues. He also explained that the two four way stop intersections proposed on South D Street are on the east and west sides of the library and that citizen foot traffic to the library has also been a big concern over the last 6-8 years as library programing usage has increased drastically. Library Director Megan Svoboda also confirmed that 300-400 children take part in the summer reading programs each year and children are also walking to the library after school daily.

Corey Clay, a resident at 911 Nome Street and former resident of South D and 6th Street, spoke in favor of the additional stop signs stating that he personally experienced driver's driving too fast, traffic accidents and near misses from people not paying attention. Captain Anderson also added that BBPD agrees with all the changes outlined in the proposed Ordinance because the department has had many traffic accidents at each intersection and some of the intersections are difficult so see around. Moved by Holland, seconded by Wamsley to close public hearing at 6:24 pm. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Smith, seconded by Wamsley, to <u>not</u> waive the three readings of Ordinance 1296, providing for the placement of stop signs located at S. 6th Ave and S. C St., S. 7th Ave and S. C St., a four way stop at the S. 6th Ave and S. D St. intersection and a four way stop at S. 7th Ave and S. D St. intersection in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion Carried.

The first reading of Ordinance 1296 was performed by City Clerk Jennifer Waterhouse.

Moved by Wamsley, seconded by Holland to open a public hearing at 6:26 pm regarding Ordinance 1297, providing for the placement of stop signs at the N. 9th Ave and N, H St. intersection creating a four way stop in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried. Discussion was held. Mayor Sonnichsen started by reading some concerns about this Ordinance given to him by Councilmember Kleeb who was unable to be at the meeting. Kleeb's concern was centered around Nebraska DOT's Manual of Uniform Traffic Control Devices and suggested that alternative considerations to promote safety should be explored for this intersection. Mayor Sonnichsen stated that council and administration will investigate the issue in greater detail.

Mayor Sonnichsen also explained that the intersection also has some vision issues at the intersection. Captain Anderson stated that this intersection has seen many near misses because the bushes along the property to the north of the intersection and vehicles parked to the south of the intersection make it hard to see around the corners. He explained that many drivers must roll into the intersection to be

able to see past the problem areas and that getting kids safely across this intersection is a major concern.

Andrew Lacy from KBEAR 92.3, stated that their station is close to this intersection, and it is his opinion that something needs to be done because the visibility is not great and there are a lot of cars and traffic in the area. He further expressed his concern over the safety of children and school groups that must cross the intersection daily. Moved by Holland, seconded by Wamsley to close public hearing at 6:33 pm. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Wamsley, seconded by Smith, to <u>not</u> waive the three readings of Ordinance 1297, providing for the placement of stop signs at the N. 9th Ave and N. H St. intersection creating a four way stop in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion Carried.

The first reading of Ordinance 1297 was performed by City Clerk Jennifer Waterhouse.

Moved by Wamsley, seconded by Holland to open a public hearing at 6:35 pm regarding Ordinance 1298, providing for the speed limit change to 25 mph for all of S. B St. west of S. 10th Ave in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried. Discussion was held. Mayor Sonnichsen said that this change would return the speed limit back to the 25 mph state standard for residential streets and is recommended by Chief Scott. Captain Anderson said that the speed was previously lowered due to construction at the city square and that it never got returned to 25 mph. Moved by Holland, seconded by Wamsley to close public hearing at 6:38 pm. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion carried.

Moved by Smith, seconded by Holland, to <u>not</u> waive the three readings of Ordinance 1298, providing for the speed limit change to 25 mph for all of S. B St. west of S. 10th Ave in the City of Broken Bow. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion Carried.

The first reading of Ordinance 1298 was performed by City Clerk Jennifer Waterhouse.

During public comments, Administrator Schmidt said that in the early morning hours on February 20th, the power plant exploded, and it is currently completely shut down. He stated that Broken Bow will not be generating power for a long time but still hopes to in the future. He explained that preliminary data shows that the probable root cause to the incident was a crank case explosion inside of engine #5. He said that the massive mechanical failure inside the engine caused a chain of events, resulting in a valve cover blowing off and ending up in the electrical bus, causing a massive short and the subsequent fire. He expressed his thanks to the city electrical department and all the electrical crews that helped the City of Broken Bow respond to the event, all first responders and city personnel. He concluded by thanking the citizens for being understanding while the power was restored during those 33 hours.

Fire Chief Watson also gave an update on the grass fires that they have been monitoring since the initial call on Monday night. He thanked the City for opening the armory to house the fire fighters that came to provide mutual aid. Mayor Sonnichsen also thanked Chief Watson for his outstanding job in such demanding situations.

During Mayor and council comments, Councilmember Holland also thanked the Police Department and EMS for doing welfare checks during the freezing weather and power outages. He also thanked the Public Information Officer for relaying information to the public during the difficult last few weeks. Mayor Sonnichsen finished with a special thank you to the media for all the ways that they keep citizens updated during these events.

Moved by Smith, seconded by Holland, to adjourn the City Council meeting at 6:50 pm. Roll Call vote: Voting aye: Smith, Wamsley, and Holland. Nays: None. Motion Carried.





AN ORDINANCE PROVIDING FOR THE SPEED LIMIT TO BE 25 MPH FOR ALL OF SOUTH B STREET WEST OF SOUTH 10TH AVENUE IN THE CITY OF BROKEN BOW, CUSTER COUNTY, NEBRASKA, PROVIDING FOR PUBLICATION AND EFFECTIVE DATE AND REPEALING ALL ORDINANCES IN CONFLICT WITH THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BROKEN BOW, NEBRASKA:

Section 1. Upon the passage of this ordinance, the speed limit for all of South B Street west of South 10th Avenue in the City of Broken Bow, Custer County, Nebraska, shall be 25 mph.

AN ORDINANCE AMENDING CHAPTER 73: PROVIDING FOR THE OPERATION OF ALL-TERRAIN VEHICLES AND UTILITY TYPE VEHICLES WITHIN THE CORPORATE LIMITS UNDER CERTAIN CIRCUMSTANCES; TO IMPOSE RESTRICTIONS ON THE USE OF ALL-TERRAIN VEHICLES OR UTILITY TYPE VEHICLES; TO ESTABLISH PENALTIES FOR VIOLATION; PROVIDING FOR PUBLICATION AND EFFECTIVE DATE AND REPEALING ALL ORDINANCES IN CONFLICT WITH THIS ORDINANCE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF BROKEN BOW, NEBRASKA:

Section 1: Amending Chapter 73 of the Municipal Code of Broken Bow, Nebraska as follows:

CHAPTER 73: ALL-TERRAIN VEHICLES AND UTILITY TYPE VEHICLES §73.01 DEFINITIONS.

For the purpose of Chapter 73 the following definitions shall apply unless the context clearly indicates or requires a different meaning.

All-Terrain Vehicle. All-terrain vehicle means any motorized off-highway device which (1) is fifty inches or less in width, (2) travels on three or more nonhighway tires, and (3) is designed for operator use only with no passengers or is specifically designed by the original manufacturer for the operator and one passenger. (Neb. Rev. Stat. 60-6,355)

Street or Highway. The entire width between the boundary limits of any street, road, avenue, boulevard, or way which is publicly maintained when any part thereof open to the use of the public for purposes of vehicular travel. (Neb. Rev. Stat. 60-624)

Utility Type Vehicle. Utility-type vehicle means any motorized off-highway device which (a) is seventy-four inches in width or less, (b) is not more than one hundred eighty inches, including the bumper, in length, and (c) travels on four or more nonhighway tires. Utility-type vehicle does not include all-terrain vehicles, golf car vehicles, or low-speed vehicles. (Neb. Rev. Stat. 60-135.01, 60-358.01 and 60-6,355)

§73.02 OPERATION.

(A) An all-terrain vehicle or utility type vehicle may be operated on streets and highways within the corporate limits of the City only if the operator and the vehicle comply with the provisions of this section.

- (B) An all-terrain vehicle and a utility type vehicle may be operated only between the hours of sunrise and sunset and shall not be operated at a speed in excess of 30 miles per hour or the posted speed limit, whichever is less. When operating an all-terrain vehicle or utility type vehicle as authorized in subsection (A) of this section, the headlight and taillight of the vehicle shall be on and the vehicle shall be equipped with a bicycle safety flag which extends not less than five feet above ground attached to the rear of such vehicle. The bicycle safety flag shall be triangular in shape with an area of not less than thirty square inches and shall be day-glow in color.
- (C) It shall be unlawful for any person to operate, or be in actual physical control of any all-terrain or utility type vehicle upon the traveled portion of any public roadway within the corporate limits of the City except as specifically authorized and permitted under the terms of this ordinance.
- (D) Any person operating an all-terrain or utility type vehicle as authorized in subsection (B) of this section shall:
 - (a) Be at least eighteen (18) years of age.
 - (b) Have a valid Class O operator's license.
 - (c) Have a permit issued by the Broken Bow Police Department permitting operation within the corporate limits of the City.
 - (d) Have liability insurance coverage for the all-terrain vehicle or utility type vehicle while operating the all-terrain vehicle or utility type vehicle on a street or highway. The person operating the all-terrain vehicle or utility type vehicle shall maintain proof of such insurance with the vehicle and shall provide proof of insurance coverage to any peace officer requesting such proof within five (5) days of such a request.
 - (e) Operators of all-terrain vehicles must wear a helmet approved for operation of a motorcycle.
 - (f) No passengers are allowed on an all-terrain vehicle.
 - (E) Every ATV and UTV shall be equipped with:
 - (a) At least one working headlight and taillight.
 - (b) A working brake light.
 - (c) At least one rearview mirror.

- (d) A working seatbelt on utility type vehicle.
- (e) A bicycle safety flag in compliance with §73.02 (B) of this ordinance.
- (f) A brake system maintained in good operating condition.
- (g) A muffler system in good working condition properly attached to the all-terrain or utility type vehicle which reduces the noise of operation of the motor to the minimum necessary for operation. The muffler shall not be audible for a distance of more than five hundred (500) feet. No person shall use a muffler cutout, by-pass, straight pipe, or similar device on an all-terrain vehicle or utility type vehicle.
- (h) A United States Forest Service-qualified spark arrester.
- (g) Two working turn signals.
- (F) ATVs and UTVs may be operated for snow removal within the corporate limits of the City of Broken Bow for 72 hours after the cessation of a snow event. Each ATV or UTV shall be equipped with:
 - (a) A bicycle safety flag in compliance with §73.02 (B) of this ordinance.
 - (b) A brake system maintained in good operating condition.
 - (c) An adequate muffler system in good working condition.
 - (d) A United State Forest Service-qualified spark arrester.
- (G) All-terrain vehicles and utility type vehicles may be operated without complying with subsections (B) and (D) of this section on streets and highways in parades, which have been authorized, by the State of Nebraska or any department, board, commission, or political subdivision of the state.
- (H) An all-terrain or utility-type vehicle shall not be operated on any controlled-access highway with more than two (2) marked traffic lanes, and the crossing of any controlled-access highway with more than two (2) marked traffic lanes shall not be permitted. Subsections (A) through (F) and (H) of this section authorize and apply to operation of an all-terrain or utility type only on a street or highway other than a controlled-access highway with more than two (2) marked traffic lanes.
- (I) Subject to subsection (H) of this section, the crossing of a street of highway shall be permitted by an all-terrain or utility type vehicle without complying with subsections (A) and (H) of this section only if:

- (a) The crossing is made at an angle of approximately ninety degrees to the direction of the street or highway and at a place where no obstruction prevents a quick and safe crossing.
- (b) The vehicle is brought to a complete stop before crossing the shoulder or roadway of the street or highway.
- (c) The operator yields the right-of-way to all oncoming traffic that constitutes an immediate potential hazard.
- (d) In crossing a divided highway, the crossing is made only at an intersection of such highway with another highway.
- (e) Both the headlight and taillight of the vehicle are on when the crossing is made.

(Neb. Rev. Stat. 60-6,356)

- (A) In order to obtain a permit to operate an all-terrain or utility type vehicle within the corporate limits of the City, an applicant must make an annual application therefor at the office of the Police Department and provide the following information:
 - (a) Name and address of the applicant.
 - (b) Proof of insurance for the all-terrain or utility-type vehicle(s) to be operated within the City by the applicant.
 - (c) Valid Class O operator's license issued by the State of Nebraska.
 - (d) Year, make, model, color, engine size, and vehicle identification number (VIN) of the utility type vehicle(s) to be operated within the City by the applicant.
- (B) In addition, the all-terrain or utility type vehicle must pass inspection by a person designated by the City to insure that the vehicle meets the requirements in §73.02 (E).
- (C) Upon compliance with sections (A) and (B) herein, and payment of an application fee of \$30.00 for initial permit and a \$25.00 annual renewal fee, with fees may be amended from time to time by resolution of the City Council, the Police Department shall issue the applicant a permit to operate the designated vehicle(s) within the corporate limits of the City and one (1) permit plate which are equal in size to a vehicle license plate issued by the State of Nebraska to attach to the rear of the vehicle.

- (D) Permits to operate the vehicle shall be valid from the date of issuance until midnight on the 31st day of December of the year for which the permit is issued.
- (E) The permit plate shall be prominently displayed on the rear fender or similar component of the operator's all-terrain or utility type vehicle.

§73.04 TRAFFIC REGULATIONS

The operator of an all-terrain or utility type vehicle within the corporate limits of the City shall comply with, and is subject to, all traffic regulations of the City and the State of Nebraska, including but not limited to, those laws, ordinances, or regulations pertaining to the operation or being in actual physical control of a motor vehicle while under the influence of alcoholic liquor or of any drug. When making turns within the roadways and at intersections, the operator shall use the appropriate hand signals as designated by the State of Nebraska Rules of the Road.

§73.05 VIOLATION AND REVOCATION OF PERMIT

Violations of these provisions shall be punishable as set forth in Section 10.99 of the Broken Bow City Code. In addition, any person receiving three (3) or more citations within a twelve (12) month period shall, upon conviction of the third or subsequent offense, have his or her permit to operate an all-terrain or utility type vehicle with the City limits revoked for a period of one (1) year from the date of conviction. Upon completion of the revocation period, said person must reapply for a permit in order to operate an all-terrain or utility type vehicle within the City limits.

Section 2. This ordinance shall be in full force and take effect from and after its passage and publication.
